### Statement of Purpose

The purpose of this agreement is to facilitate student academic transfer and provide a smooth transition from Southern Maine Community College (SMCC) to University of Maine Farmington (UMF) is recognized that this agreement shall describe the required program of study at SMCC for admission eligibility to University of Maine at Farmington and the degree program indicated.

### Terms & Conditions of Academic Credit Transfer

## To: Bachelor of Science in Elementary Education

#### From: Associate in Science in Education

The evaluation and transfer of earned college credits shall be in compliance with state and federal education policies and institutional and academic program accreditation standards pertaining to undergraduate academic transfer. Current students and graduates who have earned degrees from Southern Maine Community College shall be eligible for credit evaluation under the terms of this agreement.

Transfer students will be accorded the same standards and criteria for admission to a major degree sequence as UMF students. All applicants accepted to UMF's Baccalaureate programs must fulfill the graduation requirements of the granting institution as identified in Appendices A, B & C.

### **APPENDIX A**

### Admission & Graduation Requirements of the Receiving Institution

This agreement includes specific requirements for admission into a program, outlines requirements, and indicates which degree or diploma can be used to meet program prerequisites as well as general education, major or program, and graduation requirements.

### Admissions Requirements

Successful completion of the SMCC Associate in Science in Education, submission of a completed admission application, transcripts and other supporting materials. For coursework to transfer to UMF, a student must earn a grade of C- or better.

### **Requirements for the Bachelor of Science in Elementary Education**

#### (See Appendix C)

Remaining required course work is listed in Appendix C; a complete list of required courses can be found here <u>https://www.umf.maine.edu/academics/academic-catalogs/</u>.

Students must have grades of B- or higher in all their professional education courses, with the possibility of one exemption for extenuating circumstances (although the student must earn a minimum grade of C- in that particular course), while attaining an accumulative GPA of 2.750 or higher to graduate. Practicum courses cannot be considered for this exemption.

### Residency Requirement

All students in baccalaureate degree programs must earn the following from the University of Maine at Farmington: 1) a minimum of 18 of the credits required by their major program(s) at the 200 level or above\*, and 2) a minimum of 30 of the total required credits.

\*An academic program may require that more than 18 credits of advanced coursework and/or specific coursework, such as a capstone course, be completed at UMF.

#### Notes:

Students must earn a grade of B- or better in EDUC 100, EDUC 115, and EDUC 230 in order for these courses to be counted as program requirements.

Students must earn a grade of C or better in ENGL 100 in order for it to count as a program requirement.

#### Potential minor planning

With elective credits from SMCC, students may strategically complete coursework that will support their minor at UMF. Elementary Education majors do not have to choose a minor, but may do so to strengthen or expand their knowledge in a particular field of study, or add an endorsement to their initial licensure in K-6. For example:

If students want to add the middle level minor they could take disciplinary coursework (MAT, ENG, Social sciences, or Natural Sciences) that transfers to UMF with the appropriate prefixes. Other potential minors can be found in the <u>UMF</u> <u>catalog</u>. Please note that a minimum of  $\frac{1}{3}$  of the required credits must be earned at UMF for a minor to be awarded.

# **ARTICULATION IMPLEMENTATION AND AGREEMENT REVIEW**

The Chief Academic Officer designee of the collaborating institutions shall be responsible for implementing this agreement, for identifying and incorporating any changes into subsequent agreements, and for conducting a periodic review of this agreement.

This agreement becomes effective August 1, 2023 and will be reviewed Spring 2026 for renewal discussion.
